## NOTES FOR FILLING IN THE FORM

This form:

- must be filled in all its parts by the external user who requests the assignment or reactivation of University credentials needed for registration on DSV PICK
- must be sent to **registrazione.dsv@units.it** together the scanned double-sided copy of the identity document, with subject: **University credentials request - staff to be registered by DSV - User Surname Name.**

After registration, the Accreditation System will send user an e-mail with the assigned credentials.

Users who request an account reactivation and do not remember their credentials, must previously request this information from **codici@units.it** (Accreditation Service) indicating in the email subject, in Italian **“Richiesta forzatura pwd delle credenziali di Ateneo”** (this allows obtaining the password by forcing it), together with the scanned double-sided copy of the identity document.
